(*NOTE) Memberships allowed to lapse more than 90 days of the due date <u>Jan 1</u>, are considered past due and subject to the initiation fee for reinstatement Per Article IV – Dues

(**NOTE) Camp lot fees and stall fees are only payable once a member has been assigned a lot or stall. New members must request their name be added to the lot/stall (waiting) list to be considered for a lot/stall when they become available. The Camp Director is in charge of the lot/stall list and assigning lots/stalls to members.
